EDITORIAL

Liberabit. Revista Peruana de Psicología is pleased to present to the national and international academic community the first issue of volume 26 for this year.

The original articles section begins with the research conducted by Hugo Simkin, Lucrecia Borchardt Duter and Susana Azzollini on the evidence of validity of the Mini International Personality Item Pool, in which they propose the adaptation and validation of the 20-item shortened version in Argentine university students. They concluded that the instrument has appropriate psychometric properties for the local context. Next, Angela Vera Ruiz, María Ángela Prialé Valle, Agustín Espinosa Pessia and Erle Frances Ninahuanca López present the article entitled "Modeling a conceptual proposal to analyze psychosocial characteristics of Peruvian social entrepreneurs." In this study, they make a comprehensive approach to five theoretical dimensions of local social entrepreneurs, and identify the relevance of the attitudinal dimension of Positive Attitudes Towards Sustainable Practices (PASP) as the fundamental element to articulate the experiences of the participants in the concretion of their social vision. Then, Susana Frisancho, Enrique Delgado Ramos and Martín Salinas Cisneros present a research on cultural secrets and sports conflicts among soccer players of the Shipibo-Konibo indigenous people. Based on the results, they identified seven cultural secrets used by the soccer players of the indigenous people and found an instrumental moral reasoning based on retributive morality among the participants.

The brief original articles section includes the article "Effect of personality on compound reasoning" written by María del Carmen Crivelloa, Eugenia Razumiejczyk and Guillermo Macbeth, who describe the relationship between personality and propositional reasoning regarding compound negations. They found that neuroticism, extraversion and kindness personality traits relate to reasoning patterns, especially in generating specific responses in reasoning tasks with compound negation propositions. Following is the report by Sebastián Gabini on the role of affective commitment in the work—family interface and job satisfaction. He found that affective commitment (emotional bonds between employees and their organizations) partially mediates the relationships between the constructs work—family and job satisfaction of Argentine employees. Consequently, he concludes that there may be other mediating variables in the interface of the aforementioned variables. Lastly, the study by Jhonatan Navarro Loli and Abilio Afonso Lourenco deals with the validity of the internal structure and measurement invariance of the Children's Hassles Scale in adolescents. The authors report that the factor structure does not show consistent indicators in the sample of Peruvian adolescents; however, despite being different from the original factor structure, it presents robust indicators with respect to the evidence of validity of the internal structure, measurement invariance and reliability.

With this issue, prepared in exceptional circumstances as those of the first part of the year 2020, Liberabit remains current and offers its contributions for discussion and analysis by the psychological community.
